Key Highlights

The top subsector stock performer in Q3 2021 was education / academic publishers, up 1.1% quarter-overquarter

On average, EBITDA multiples for the subsectors decreased 1.8x from the prior quarter and decreased 0.1x on a year-over-year basis

Education M&A Activity in Q4 – More of the Same Or a Dose of Reality?


As our regular readers know all too well, the education M&A market has been robust for some time, with seemingly no end to growing activity levels and increasing valuations. After setting a pace that will be nearly impossible to match through the first three quarters of the year, the question today is whether or not that pace can be maintained through the fourth quarter or could we finally see a slowdown. Nearly all bets would be on sustained peak levels of activity as sellers continue to chase capital gains tax certainty and/or take advantage of the continued frothy valuation environment.

Notwithstanding the draw of advocating for one view or the other strongly, our answer to that question would be: it depends. What we have seen through Q3 and now into the early days of Q4 is a separation of the wheat from the chaff. As robust as the market has been and as aggressive as buyers have been with respect to value, the emerging trend we are seeing is a strong delineation between premium assets and non-premium assets. Businesses that were performing well pre-COVID and were able to sustain that performance at some level through 2020 and now through most of 2021 will indeed find a very receptive market. On the other hand, businesses that suffered due to COVID and/or the resulting global demand or supply chain slowdowns are finding an icy reception from investors. Even businesses that have bounced back strongly from momentary slowdowns in 2020 face probing questions about whether their products or services are truly must-have. And businesses that have performed well but may be facing limitations to their growth due to supply chain issues or momentary demand weakness are facing substantial scrutiny from would-be investors or strategic buyers about their longer-term profitability profile.

Lincoln Perspectives

Despite this growing market bifurcation, we do expect an extremely robust Q4 in terms of transaction volumes. As strained as the M&A market has become in the last 60 days due to deal proliferation, there remains a strong desire by many sellers to close transactions by year-end and eliminate any risk around potential changes to capital gains tax rates in 2022. As a result, the sheer number of transactions already in process will almost certainly dictate closed deal volumes remain at peak levels. For those considering whether or not to chase a transaction in the near term, we would encourage restraint and a healthy dose of self-awareness. If you elect to charge headlong into the market without a strong growth profile, clear product-market fit and predictable revenue streams, you will take on substantial deal execution risk. On the other hand, if those attributes are all highly favorable, the market today continues to be as robust as ever.





Two-Year Relative Stock Indices Price Performance




